NAPPY CHANGE PROCEDURE

Nappy Changing & Toileting Procedure – Statement of Intent

Our Service aims to meet the needs of all children by providing a **clean, safe, and hygienic environment** for nappy changing and toileting. We believe these daily care routines are not just about hygiene, but also **valuable opportunities for learning, trust, and relationship-building**.

Nappy changing and toileting rituals, when provided in a **caring, respectful, and responsive manner**, promote:

- **Children's learning and development** through language-rich interactions, choices, and conversations (*VEYLDF & 3A Approach*).
- **Children's rights, dignity, and safety** by ensuring privacy, seeking consent, and empowering participation (*Child Safe Standards Standard 3: Children and young people are empowered and have a voice in decisions affecting them*).
- **Health and wellbeing** by reducing the risk of infection and minimising cross-contamination through consistent hygiene practices.

This procedure works in conjunction with our **Nappy Change and Toileting Policy** and provides detailed steps for educators to follow when changing a nappy at the Service.

Nappy Changing Procedure

STEP 1: PREPARATION

Educators will:

- Ask the child for their consent before beginning (e.g., "It's time for a nappy change, is it okay if I help you onto the change mat?").
- Use back-and-forth conversation, sing songs, or talk through what they are doing, creating a positive and engaging learning moment (3A Enriched Caregiving).
- Offer choices when possible (e.g., "Would you like the red or blue toy while we do this?") to support independence and participation (*Child Safe Standards Empowerment*).

Steps:

- 1. Gather everything you need within reach (gloves, clean nappy, wipes, waterproof bag for soiled clothes/cloth nappy).
- 2. Provide a basket of toys for the child to play with (wash toys after use).
- 3. Wash hands with soap and water, dry with paper towel.
- 4. For soiled nappies or if the child has red/broken skin, put on disposable gloves.

STEP 2: CHANGING

Educators will:

- Explain each step and check in with the child ("I'm going to lift your legs now, are you ready?").
- Respond to the child's cues and body language, offering reassurance if they are uncomfortable.
- Ensure privacy and dignity are respected (Child Safe Standards Safe Environments & Respect).
- Use language-rich interactions, describing actions and noticing what the child is doing (3A Conversational Reading in routines).

Steps:

- 1. Encourage the child to walk up the steps or gently lift them onto the change table.
- 2. Always keep one hand on the child to prevent falling.
- 3. Remove the child's nappy and soiled clothing (keep cloth handy in case of urination).
- 4. Use the front of the nappy to wipe off faeces.
- 5. Using wipes, clean the child's bottom and genital area.
- 6. Hold legs gently and lift the child's bottom, wiping front to back.
- 7. Place dirty wipes inside the nappy, fold using tabs, and dispose in a hands-free bin.
- 8. Place any soiled clothes/cloth nappies in a plastic bag.
- 9. Remove paper covering and dispose in a hands-free bin.
- 10. Remove gloves, turning them inside out, and dispose safely.
- 11. If nappy cream is needed, put on new gloves.
- 12. Apply cream, then remove and dispose of gloves.
- 13. Place a clean nappy beneath the child, lift ankles gently.
- 14. Fold flap up, tuck securely, and fasten tabs (not too tight).
- 15. Dress the child and wash your hands as well as the child's hands support self-help if the child is able (3A Learning Games).
- 16. Place the child with another educator in a safe area, encouraging them to return to play.

STEP 3: NAPPY CHANGE AREA CLEANING

Educators will:

- Talk with children nearby about why cleaning is important ("We clean so germs don't make us sick") (3A Enriched Caregiving).
- Ensure hygiene and safety are always prioritised (*Child Safe Standards Safe Environments*).

Steps:

- 1. Wear utility gloves for cleaning.
- 2. Clean change table with detergent and warm water using paper towel/cloth.
- 3. Rinse mat with clean water, dry with new paper towel/cloth.
- 4. Dispose of paper towel or place cloths in wash hamper.
- 5. Wash hands thoroughly.
- 6. For spills (urine, faeces, vomit):
 - Cover with paper towel.
 - o Remove solids and paper towel, seal in bag, dispose.
 - o Clean surface with detergent and water.
 - Wash with disinfectant.
 - o Wash hands.
- 7. Change mats or waterproof sheets during the day as needed, drying in the sun where possible.
- 8. Inspect mats daily for damage (holes, cracks, rips).
- 9. At day's end, wash mat and area with soap and water, dry in sun.
- 10. Restock supplies (wipes, nappies, liners, paper mats).
- 11. Implement extra hygiene measures during outbreaks (e.g., gastro).
- 12. Clean bathroom and change area daily with sanitiser/detergent and warm water as per manufacturer instructions. Wear gloves, use paper towel, and wash hands afterwards.

IMPORTANT REMINDERS

- Always ask for the child's consent and respect their right to say "no." If a child resists, educators will acknowledge their feelings, offer comfort, and try again with reassurance.
- Never leave a child unattended on a change table.
- Disposable gloves must be worn when disposing of nappy contents.
- Liners must not be flushed.
- Soiled cloth nappies (and reusable liners) must go in a separate bag after each use.
- Children's dignity, privacy, and safety must be protected at all times (Child Safe Standards).
